# PHAB Accreditation Requirements for Ohio

Recognizing the benefits of accreditation through PHAB (Public Health Accreditation Board), the 130th General Assembly in 2013 codified the authority for the Director of Health to require all local health districts to apply for accreditation through PHAB by July 1, 2018 and to become accredited by July 1, 2020. Requiring Ohio's local health districts to become accredited by PHAB will demonstrate that they are meeting or exceeding a common set of national standards; have the capacity to provide core public health services; and are continually striving to improve service, value, and accountability to stakeholders.

A condition of receiving any funding (subsidies or grants) from the Ohio Department of Health is to meet these PHAB deadlines.

## NEW STAFF MEMBER - PUBLIC HEALTH ACCREDITATION COORDINATOR

At the April 2017 Board of Health meeting, it was determined the need was justified to hire a full-time Accreditation Coordinator to assist us in meeting the mandatory July 2018 PHAB Accreditation application deadline. The position was posted, applicants were screened, a handful were interviewed, and we are pleased to report Jenny Klein has joined our staff.

Jenny moved to Crawford County from Northwest Indiana. She studied Animal Science and Animal Agribusiness at Purdue University, West Lafayette. In addition to earning her degree, Jenny also served in the United States Marine Corps Reserve as a Field Radio Operator. Passionate



about well-being and making a difference, the transition to Crawford County Public Health Department was a natural fit. Jenny has become familiar with what a great achievement it means to be nationally recognized and accredited by the Public Health Accreditation Board and has been coordinating efforts towards reaching this accomplishment. In her free time, Jenny loves to go camping with family and her boyfriend Zach. She also has two fur babies and enjoys spending time with them outdoors. Appreciating life in a small-town community and grateful for a healthy life, Jenny strives to improve and protect the health and safety of all residents of Crawford County.


## TRAINING ASSISTANCE RECEIVED FOR ACHIEVING PHAB ACCREDITATION

The goal for Crawford County Public Health is to apply PHAB (Public Health Accreditation Board) Accreditation by July 2018! Just a few of the required documents needed prior to applying for Accreditation include the Community Health Assessment (released in 2016), the Community Health Improvement Plan (released late 2016), the Strategic Plan, Workforce Development Plan (both in progress), Quality Improvement Plan, Performance Management System, a Marketing Plan, and a Branding Strategy.

As we continue to work on PHAB document compliance, we are pleased to announce we were chosen for two (2) no-cost training & technical assistance awards funded by the Ohio Department of Health to help us achieve our goal. These awards cover the cost of training and assistance from the Ohio State University College of Public Health to support us in completing prerequisite documents needed for demonstrating PHAB compliance. The projects currently being supported by these awards include our Workforce Development Plan and our Strategic Plan. We have also applied for assistance with our Performance Management System and hope to begin that work later this year.

#### **ENVIRONMENTAL HEALTH DIVISION REPORT:**

Crawford County Public Health was awarded a 2017 OEPA grant funding to repair and/or replace failing home sewage systems countywide with emphasis on the villages of Chatfield, Tiro and North Robinson. We were awarded our full requested amount of \$300,000. Cindy Brookes from the Sandusky River Watershed Coalition is again our administrator of the grant. All possible candidates are directed to Cindy who determines their eligibility and arranges the bids for eligible projects. Our department has already identified several possible eligible properties and a few have been determined to be eligible for 2017 grant funds.

In mid-May, the EH Division Food Program underwent a survey by the Ohio Department of Health. ODH surveys the food programs of all Ohio health departments on a 3-year cycle to determine if they are meeting the standards set by ODH. This survey consists of analysis of the administrative and regulation enforcement areas of our Food Program. Our office was officially notified that we passed our survey and our Food Program remains on the approved list. Our division routinely inspects all licensed food operations within our jurisdiction.

In April, the EH Division Solid Waste Program received its annual survey by the Northwest Ohio EPA. The survey consists of review of the administrative and inspectional portions of our Solid Waste Program including all aspects of the county landfill, registered Construction and Demolition Debris sites. composting sites and infectious waste sites. As in past years, our department continues to be on the approved list by OEPA.

#### HELP ME GROW DIVISION (STATE FY 2017 FUNDING - JULY 1, 2016 TO JUNE 30, 2017)



July 1st marks a new fiscal year for Help Me Grow and Early Intervention. Last fiscal year, we had program change, most notably the transfer of the Early Intervention program from the Ohio Department of Health to the Ohio Department of Developmental Disabilities. This fiscal year, Help Me Grow will experience both program and fiscal changes. A dramatic change is that historically, families or

professionals were able to contact us by phone, fax, and text or email if they or someone they knew were interested in our services. As of August 1st, all referrals for any Ohio Help Me Grow Program or Early Intervention throughout the state of Ohio will be the responsibility of The Cleveland Sight Center.

This drastic change in the referral process, per ODH, will save money. They also say that some funds may continue to flow to locals programs like ours to do some local outreach. Crawford County has always been recognized for our ability to meet projected target numbers of families and children being served. Only time will tell how the change will affect HMG and El services in Ohio.

The other fiscal and program change is that as of June, our Healthy Families program, which was funded through a federal grant, transferred from CCPH to Marion Area Pregnancy Program (MAPP). When we were unable to expand the program due to federal budget cuts, we had to reduce staff hours. It was always a tight budget and grant payments were frequently late. Consequently, CCPH made many budget amendments to transfer money to meet payroll and other obligations. These and other decisions led to the transfer. Our Healthy Family staff have remained with us as Help Me Grow Home Visitors. They worked diligently to make the transfer as seamless as possible. Crawford County families will continue to be served and we are working together to make sure the program participants are included in local Help Me Grow Family Events.

We end this quarter with good fiscal news. Due to the great work of our Home Visiting staff, we will receive nearly \$50,000 in incentive payments for meeting positive outcomes for the families we serve. Favorable outcomes include expectant mom's keeping all prenatal appointments, pregnant women quitting smoking, delivering a full term baby, ensuring child's immunizations are up to date, and keeping 90 percent of scheduled home visits.







#### COMMUNICABLE DISEASE TRACKING & SURVEILLANCE

The number of infectious disease cases increased between May and June (12 and 21 cases respectively). Table 1. illustrates the types of illnesses reported in Crawford County during June and the number of cases for each of these conditions. Between the two months, cases of chlamydia (9 in May) and Hepatitis C (2 in May) increased. Cases of gonorrhea, Lyme Disease and Zika virus infection were also reported during the month of June. This Zika case listed here is a suspect case and additional testing is being conducted to ensure it is labeled accurately.





#### NURSING DIVISION - 2<sup>ND</sup> QUARTER HIGHLIGHTS (APRIL – JUNE)

#### <u>Immunization Program</u>

- Immunization appointment clinics are held every 1st, 4th, and any 5th Thursday 9-11:30am and 1-4pm; every 2nd and 3rd Thursday 9-11:30am and 3-6:30pm at the Health Department. We also have a clinic the 3rd Wednesday of each month from 9-11:30am at St. John's Lutheran Church in New Washington.
- A total of 286 clients were seen and 622 vaccines were given in the 2nd quarter.
- We have recently added Typhoid and Yellow Fever Vaccines to our list of travel vaccines.

#### CMH (Children with Medical Handicaps)

CMH is a health care program in the Ohio Department of Health (ODH). CMH links families of children with special health care needs to a network of quality providers and helps families obtain payment for the services their children need. CMH receives funding for services from the federal Maternal and Child Health Block Grant, state general revenue funds, county tax funds, third-party reimbursements and donations. CMH promotes early identification of children with handicapping conditions and treatment of those children by appropriate health care providers.

- We currently have 109 children we assist with this program.
- We billed \$8,010.00 in the 2nd quarter of this year.

#### **Communicable Disease Investigation**

- The Nursing Department investigated 96 communicable diseases the 2nd quarter of the year. 47 Hepatitis C; 4 Hepatitis B; 31 Chlamydia; and 13 miscellaneous diseases.
- Nurses go to Maryhaven (drug and alcohol treatment center) every 6 weeks for communicable disease education and testing. This quarter we tested 31 clients for STD's, 17 for Hepatitis C, and 20 for HIV.

#### Jail Nursing

- Nurses worked 430.5 hours at the Crawford County Justice Center.
- Statistics: 304 inmates booked in, 219 physicals completed, 368 sick inmates seen, and 54 inmates for drug and alcohol withdrawals.

#### **Sexual Health Clinic**

 We are part of a grant with Union County Health Department to provide services for a Reproductive Health and Wellness Clinic twice a month. This clinic provides affordable reproductive healthcare for men and women ages 13 and up.

#### **School Nursing**

- The Nursing Division proudly provides services for six schools in our county: Buckeye Central, Bucyrus, Colonel Crawford, Crestline, Crestline St. Joes and Wynford. We also fill in for the nurse at Fairway/Waycraft as needed.
- The nurses at the schools are always very busy seeing students for: accidents, illnesses, head lice checks, blood sugar checks and insulin administration, administration of medications, vision and hearing screenings, phone calls to parents and Doctors, reviewing records, blood pressures, mandated reporting in abuse cases, referrals and whatever else may happen during school hours.
- Below is a summary of the services provided by our nurses at each of the five public schools we served for the 2016-2017 school year.

#### WIC 3rd Quarter for FY17


- For FY17 our Grant that we were awarded is for \$299,552. The Grant is from 10/01/2016-09/30/2017. At the end of the 3rd Quarter we have spent approximately 67% of the Grant.
- I have attended Crawford Community Council, Crawford Childhood Initiative, Family and Children First, Prenatal Outcomes, Dream Child Conference, Monthly Board meetings, Directors meeting, NW District Director meeting. Help Me Grow staff have been hanging out at our clinics to try and recruit more kids for their program.
- What is going on at WIC; we continue to educate participants on Nutrition and Breastfeeding, along with being a referral program to the many different agencies in the community. We continue to work with the Health Department to make sure our participants are up to date on all of the immunizations that they need and lead screenings. We work with Help Me Grow by referring many of our new pregnant moms to their program for the guidance they may need as a new parent, or a parent of many, or referrals to agencies that may help them in their journey as a parent.
- We had our Management Evaluation May 23-25. This is our state evaluation that is done every 2 years. We did great, we had 3 Corrective Actions that were minor and will be easy to evaluate and correct.
