## Quarterly Report to the Crawford District Advisory Council

### ALIGNING LOCAL EFFORTS WITH THE STATE HEALTH IMPROVEMENT PLAN

A new state law took effect in 2016 requiring tax-exempt hospitals (like Avita) and local health departments to work together to create a community health assessment (CHA) and a local community health improvement plan (CHIP) every three years. To promote alignment and coordination of efforts to improve health outcomes in Ohio, the local CHIP is to align with at least two state plan health priorities and at least one state plan core outcome indicator for each of the chosen priorities.

The three priority health topics in the 2017-2019 State Health Improvement Plan are:

- Mental Health & Addiction – including outcomes for drug dependence and abuse, drug overdose deaths, depression and suicide.
- Maternal & Infant Health – including outcomes for infant mortality, preterm births and low birth weight.
- Chronic Disease – including outcomes for heart disease, diabetes and child asthma.

The four priority health topics in the local Crawford County Health Improvement Plan (CHIP) are:

- Decrease Obesity – through healthier foods choices, increasing worksite wellness programs, increasing education on healthy eating.
- Decrease Adult Cardiovascular Disease – initiating walking programs, increasing education, implementing tobacco-free policies.
- Decrease Youth Substance Abuse – increasing awareness of trauma informed care, expanding on the Operation Street Smart program, enhancing the Leader In Me program, increasing screening for depression during office visits.
- Improve Prenatal Outcomes – exploring the Pathways Model, increasing the use of safe sleep practices, increasing breastfeeding practice.

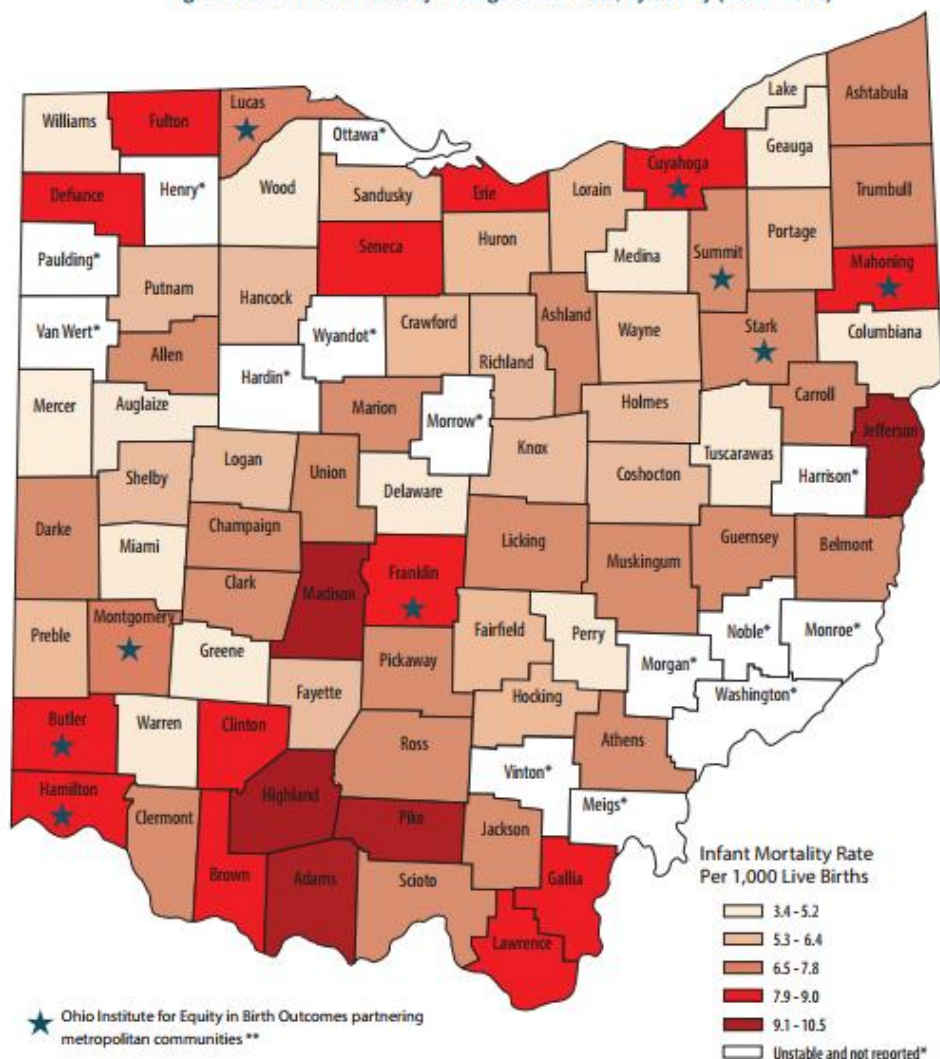

## 2016 OHIO INFANT MORTALITY

The Ohio Dept. of Health recently released the 2016 data on infant mortality (infants that died before their first birthday). Overall, the 2016 number of infant deaths rose 1.9% (1,024 Ohio infant deaths in 2016 compared to 1,005 in 2015), but the number of sleep-related deaths declined. Prematurity-related conditions continues to be the leading cause of infant death in Ohio. Factors associated with prematurity-related conditions include genetic issues, overall health of the mother, conditions like diabetes or high blood pressure, smoking, and birth intervals shorter than 18 months which allow less time for a woman's body to recover between pregnancies. Ohio's target is to achieve fewer than 6.0 infant deaths per 1,000 live births for all racial and ethnic groups but currently has an overall rate of 7.4 infant deaths per 1,000 live births. The 5-year average infant mortality rate for Crawford County for years 2012-2016 is 5.5 infant deaths per 1,000 births.

Infant mortality rate county groupings were determined by Jenks Natural Breaks. This method finds the best way to split up the ranges by minimizing the variation within each group, so the areas within each color are as close as possible in value to each other.

\* Rates based on fewer than 10 infant deaths are unstable and not reported.

\*\* Ohio Institute for Equity in Birth Outcomes partnering communities seek to improve overall birth outcomes and reduce racial and ethnic disparities in infant mortality. These metropolitan areas accounted for 59 percent of all infant deaths, and 86 percent of black infant deaths, in Ohio in 2016.

## PHAB ACCREDITATION PROGRESS UPDATES

### All Staff Accreditation Meetings

- Our first Accreditation All-Staff Meeting took place the beginning of August and recurs the first Tuesday of every month. This allows all staff to share updates on documentation gathering, discuss any problems or concerns, and ask questions throughout our process in achieving accreditation. Individuals were divided into "Domain Teams" during this time. These domains represent the 10 Essential Public Health Services, with the addition of governance and administrative services. Teams have been meeting once to twice a week to work on documentation selection and uploading.

### Workforce Development

- Upon receiving training assistance provided by the Ohio State University, we began the writing of our Agency's Workforce Development plan the beginning of July. This plan will help identify gaps in knowledge, skills, and abilities of our agency's workforce. We have administered multiple surveys this quarter to gather data including a Core Competency Survey, Training Needs Assessment Survey, and an Employee Satisfaction Survey. The completion of a workforce development plan will strengthen our ability to address these discovered gaps through targeted training and development opportunities, which is also a section included in the plan.

### Strategic Plan

- Developing our agency's Strategic Plan began in the month of September. This consists of in-house sessions through the Ohio State University College of Public Health extension as well. Our agency's Strategic Plan will include our defined mission statement, vision statement, values, and the primary 3-year goals and objectives of our agency. A survey was conducted in order to gather input from employees, board members, and community partners.

A portion of the Strategic Plan development includes the completion of a SOAR (Strengths, Opportunities, Aspirations, and Results) analysis. When CCPH employees were asked to choose core values that describe how we conduct ourselves, the top ten chosen were:

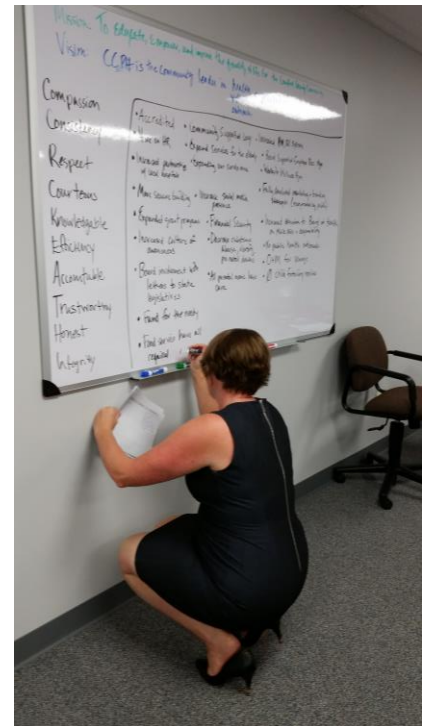

## ENVIRONMENTAL HEALTH DIVISION REPORT:

Crawford County Public Health EH Division applied for the 2018 OEPA grant funding to repair and/or replace failing home sewage systems. If awarded, we will focus this funding countywide with emphasis on the villages of Chatfield, Tiro, and North Robinson. We have applied for the maximum amount that can be awarded to a health jurisdiction for the 2018 cycle, \$200,000. Cindy Brookes from WSOS has again graciously agreed to be our administrator of the grant.

The 2016 OEPA grant funds have mostly been utilized by many eligible Oceola residents and a few in other parts of the county. Four systems have been installed in Oceola with the remaining systems hopefully undergoing installation in October. The 2016 grant cycle will officially end in November 2017.

The 2017 grant has 7 individuals that have been deemed eligible for funding. 6 of those will receive 100% coverage and the seventh is eligible for 85% coverage. These systems are currently in the bidding process for soil analysis, designs, and installation. Our department continues to seek more households that may benefit from the 2017 sewage grant.

In August, the EH Division Pool Program underwent a survey by the Ohio Department of Health (ODH). ODH surveys the pool programs in all Ohio health departments on an annual cycle to determine if they are meeting the standards set by ODH. Preliminary results from our surveyor indicate that we passed our survey and our Pool Program will remain on the approved list. Our division routinely inspects all licensed public pool & spa operations in the county (8 main pools and 6 additional pools/spas at same location).

The Bratwurst Festival was August 17<sup>th</sup>-19<sup>th</sup>. Our office conducted 76 food inspections during that festival.

CCPH started planning the upcoming 2018 exercises. On February 22, 2018 we will practice a county-wide snowstorm event (hopefully not a jinx). On March 2, 2018 we will be participating in the Local Emergency Planning Committee (LEPC) tabletop exercise. In October 2018 we will be conducting a Vaccination Drive-Through Clinic exercise.

We have started Revision 2.0 of the Emergency Response Plan. Work is half completed on the new plans and promulgation is scheduled for May 2018.



## NEW PROGRAM – BED BUG EDUCATION:

August kicked off the bed bug program. Crawford County Job & Family Services is partnering with us and Carothers Pest Control to offer FREE bed bug treatments as long as an education component is met prior to treatment. Low income families with children qualify for financial assistance to cover the costs of treating their home. The interactive, 1-hour class our office provides offers participants solutions that they can do themselves to help with the exterminations process. ## HELP ME GROW DIVISION (STATE FY 2018 FUNDING - JULY 1, 2017 TO JUNE 30, 2018)

As reported in our last DAC quarterly report, July 1<sup>st</sup> marks a new fiscal year for our Help Me Grow Home Visiting Program. This program promotes healthy growth and development for Ohio's babies and young children. Our Home Visitors provide caring support and reliable information on topics such as soothing a crying baby, how to manage sleep or how to deal with the stresses of parenting. All of our Home Visitors have their "Happiest Baby" Educator Certificate and enjoy promoting the 5 S's to a good night's sleep. In case you are wondering they are Swaddle, Side/Stomach Position, Shushing, Swinging, and Sucking. When done the right way your baby (and mom and dad) will sleep much better. Last fiscal year our Home Visitors made 1,507 home visits.



July 1<sup>st</sup> also marks a new fiscal year for our Early Intervention Service Coordination grant. Early Intervention provides support to parents of infants and toddlers with disabilities. Whenever a parent has a concern about their child's development, Crawford County Public Health Service Coordinators meet with the family, determine if the child meets eligibility criteria either through a play based evaluation or medical documentation. Once eligibility is established the Service Coordinator



develops a service plan identifying the supports and services that will maximize the child's development. All Early Intervention Services are provided in the child's home. We partner with Fairway School to provide Physical Therapy, Occupational Therapy, Speech Therapy, and Specialized Instruction through Developmental Therapists. Last year we completed 387 home visits for the Early Intervention program.

Our staff is also participating in our community's health improvement plan by meeting with community partners on improving prenatal outcomes. HMG collaborates with many community agencies including GRADS program at PJVS, Head Start, Job & Family Services, Economic Partnership, Community Counseling, libraries, and our area schools.



Each month we hold Family Connections meetings. It is a time for learning, having fun and building relationships. This quarter our Help Me Grow families enjoyed our gatherings at the School Carnival at United Methodist Church in Bucyrus, Splash Park in Galion and Lowe Volk Park in Crestline. Preparations are also underway for our annual Help Me Grow Holiday Open House planned for December 4 at CCPH.

## COMMUNICABLE DISEASE TRACKING & SURVEILLANCE

The number of infectious disease cases decreased between August and September (23 and 19 cases, respectively). **Table 1.** illustrates the types of illnesses reported in Crawford County during September and the number of cases for each of these conditions. Between the two months, cases of chlamydia (9 in August), gonorrhea (2 in August), and Hepatitis B (6 in August) decreased while cases of Hepatitis C (3 in August) increased. Additionally, cases of anaplasmosis, campylobacteriosis, and *Streptococcus pneumoniae* were also reported during the month of September.

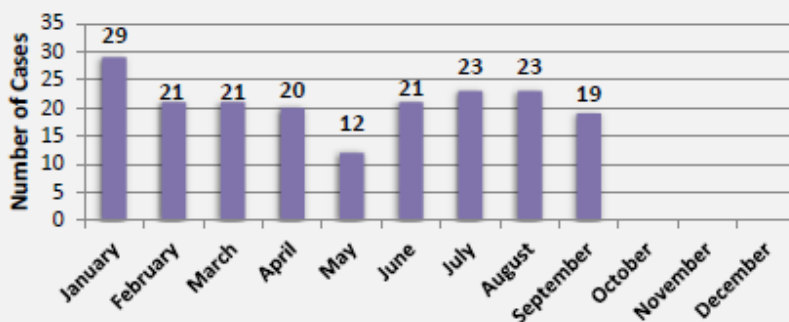

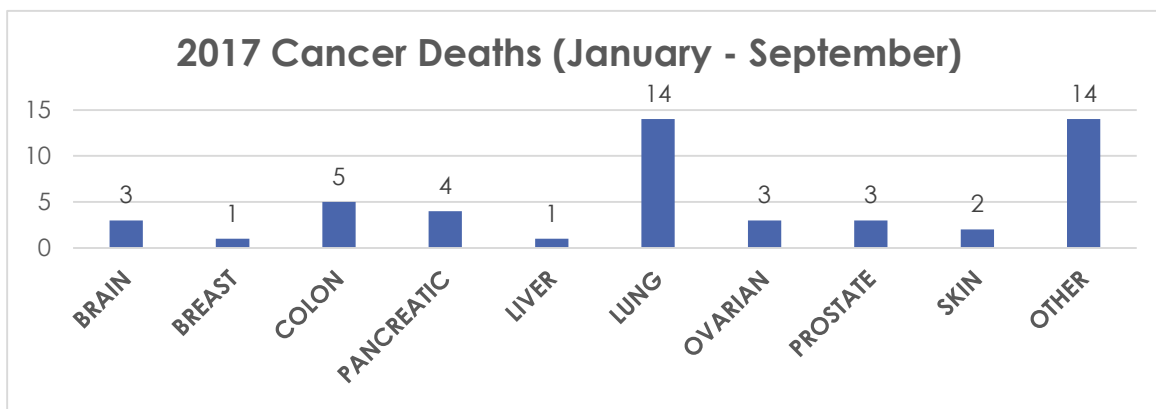
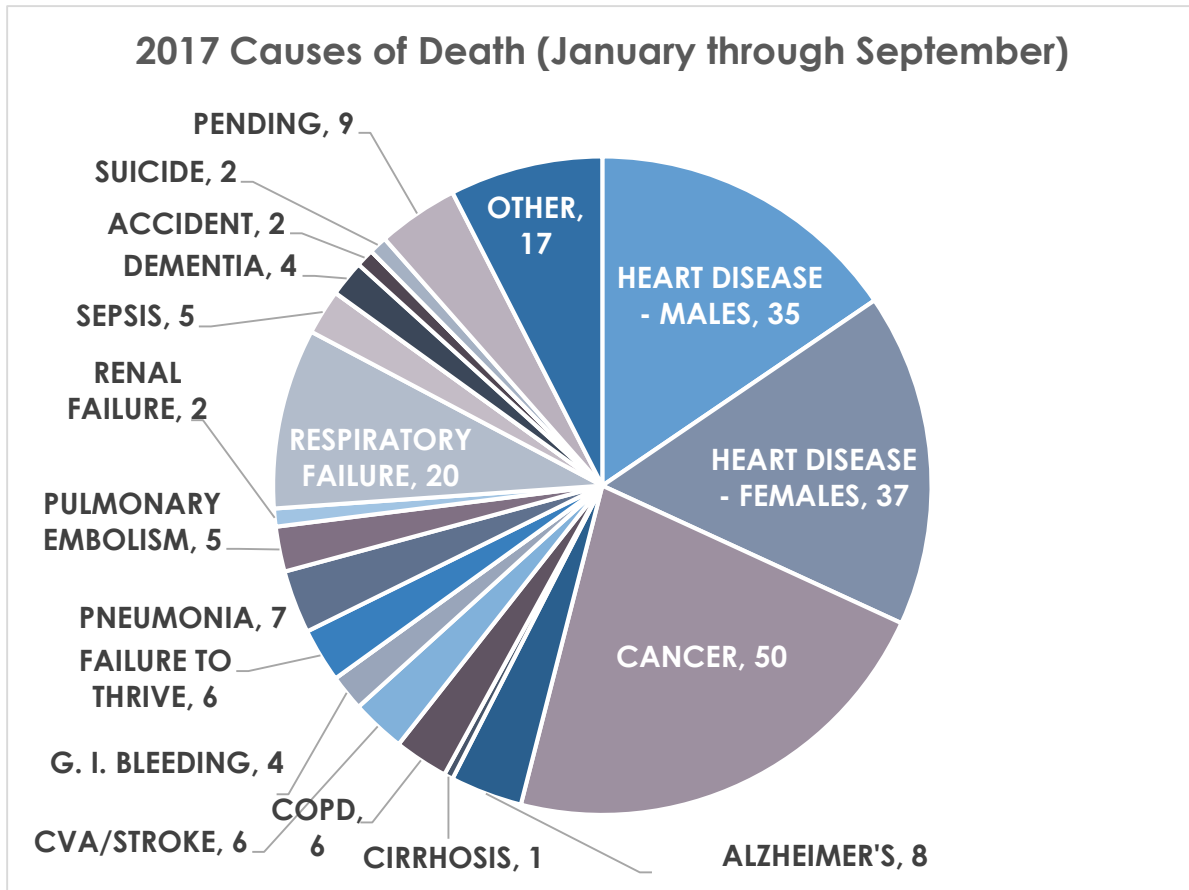

## NURSING DIVISION - 3<sup>RD</sup> QUARTER HIGHLIGHTS (JULY - SEPTEMBER)

### Immunization Program

- Immunization clinics are held every 1<sup>st</sup>, 4<sup>th</sup>, and any 5<sup>th</sup> Thursday 9-11:30am and 1-4pm; every 2<sup>nd</sup> and 3<sup>rd</sup> Thursday 9-11:30am and 3-6:30pm at the Health Department. We also have a clinic every 3<sup>rd</sup> Wednesday from 9-11:30am at St. John's Lutheran Church in New Washington.
- A total of 566 clients were seen and 1,201 vaccines were given this quarter.
- To accommodate the students needing vaccines prior to going back to school, we held 13 immunization clinics in August (6 had evening hours & 5 were held in local schools).

### Communicable Disease Investigation

- The Nursing Department investigated 120 communicable diseases the 3rd quarter of the year. 60 Hepatitis C, 9 Hepatitis B, 30 Chlamydia and 21 miscellaneous diseases.
- Nurses go to Maryhaven (drug and alcohol treatment center) every 6 weeks for communicable disease education and testing.

### Jail Nursing

- Nurses provided 495 hours at the Crawford County Justice Center.
- Statistics: 310 inmates booked in, 209 physicals completed, 285 sick inmates seen, and 43 inmates seen for drug and alcohol withdrawals.

### CMH (Children with Medical Handicaps)

- The Children with Medical Handicaps Program (CMH) is a health care program in the Ohio Department of Health (ODH). BCMH links families of children with special health care needs to a network of quality providers and helps families obtain payment for the services their children need. BCMH receives funding for services from the federal Maternal and Child Health Block Grant, state general revenue funds, county tax funds, third-party reimbursements and donations. BCMH promotes early identification of children with handicapping conditions and treatment of those children by appropriate health care providers.
- We currently have 107 children we assist with this program.

### This is WIC's 4th Quarter for FY17

- For FY17, our Grant award was for \$299,552. The Grant was from 10/01/2016-09/30/2017. At the end of the 4<sup>th</sup> Quarter we spent approximately 94% of the Grant.
- We have attended Crawford Community Council, Crawford Childhood Initiative, Family and Children First, Prenatal Outcomes, Dream Child Conference, Monthly Board meetings, and Directors meeting.
- We continue to educate participants on Nutrition and Breastfeeding, along with being a referral program to the many different agencies in the community. We continue to work with the Health Department to make sure our participants are up to date on all of the immunizations that they need and lead screenings. We work with Help Me Grow by referring many of our new pregnant moms to their program for the guidance they may need as a new parent, or a parent of many, or referrals to agencies that may help them in their journey as a parent.
- To celebrate Breastfeeding Awareness Month, we had an awesome baby shower event at Avita Hospital in Galion that was attended by pregnant moms and their support person. We gave away door prizes, baby blankets donated by St. John's Lutheran Church (New Washington), gift bags, and had several Partner Agencies from the community available to talk with the parents. We also had a wide variety of food supplied by the hospital. This was our 14<sup>th</sup> year to collaborate with the hospital on this community baby shower. 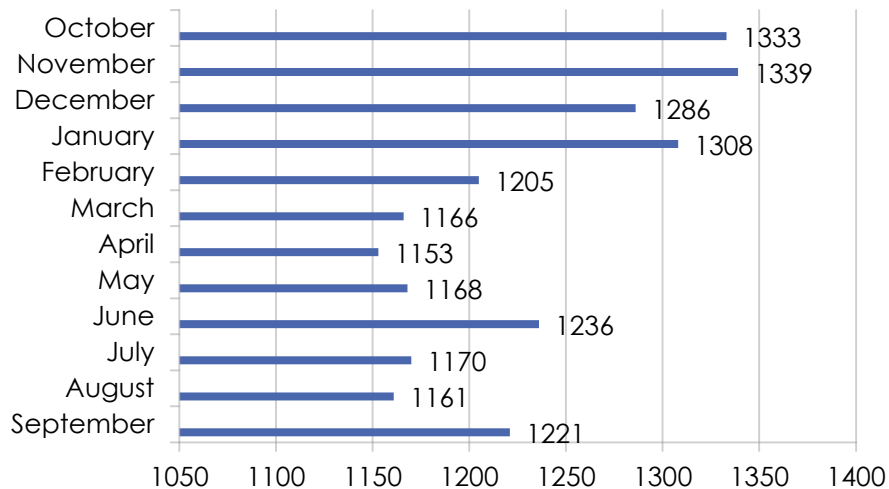
